

## Professional Concerns Committee Minutes of 20 November 2024

### **Call to Order**

The regular meeting of the Western Michigan University Faculty Senate Professional Concerns Committee was called to order at 1:32 p.m. on 20 November 2024, via Webex conferencing by Michael Kahwaji, chair.

#### Quorum

A quorum was present with nine members in attendance, of the five needed to establish quorum.

#### Agenda

The agenda was amended to add Unfinished Business – definition of "clinical". It was moved by Triplett, seconded by Miller, to accept the agenda as amended. The motion carried.

#### **Minutes**

An amendment was made to change Kahwaji as nominated, not self-nominated. It was moved by VanDerwall, seconded by Simpson, to approve the 23 October 2024 minutes as amended. With four abstentions, the motion carried.

### **Reports of Officers**

Chair Kahwaji will work with Ex Officio Simpson and the Faculty Senate Executive Board to define "clinical".

Ex Officio Simpson stated that the definition of "clinical" is necessary to ensure proper representation and due process for grading and program dismissal appeals for clinical courses and clinical- or technical-expertise-oriented programs. A Memorandum of Action (MOA) may be requested from PCC addressing these concerns. An associated concern was the involvement of university administration in resolution of the triggering case.

# **Reports of University Representatives**

Erskine is active with standard uptick in academic misconduct reports with progression of term.

McConnell discussed the following:

- 1. General outlines of the underlying student appeals that uncovered the complications associated with clinical and expertise-oriented programs. One focus is the interplay of Hardship and Program Dismissal:
- Ombuds' forms changes for Hardship and Grade Appeals, as reviewed by PCC, have been implements;
- 3. Efforts to recruit additional faculty to serve on various appeals committees have been successful with many new members in the pool.
