



SRC Membership Terms

Security and ID Policy

The Western Michigan University security system operated by the Department of Public Safety (DPS) is designed to protect our facility and to ensure all users have proper authorization. Any person wishing to enter the activity spaces within the Student Recreation Center (SRC) must purchase access rights according to the facility fee structure and obtain an ID card that allows access into the control zone. An active, working Bronco Card, WMU affiliate ID, or a guest pass and picture ID are acceptable forms of identification for admittance and may be used only by the owner. ID cards used by individuals other than the owner will be confiscated. The confiscated ID card will be sent to DPS and access will be suspended. Offenders are also subject to the Misconduct Policy.

Risk Statement

Participation in recreational activities, intramural sports, fitness programs and special events is purely voluntary, and individuals participate at their own risk. It is recommended that you consult a physician prior to beginning any exercise program. Participants should be aware of the possibilities of bodily injury and should understand that they are responsible for all costs arising out of injury or property damage sustained through participation. Should somebody become injured, please notify a program or facility supervisor for assistance.

Guest Pass Policy

Members may sponsor up to two guests at a time to use the SRC. Guests must be 16 years or older, produce a picture ID, and be accompanied by the sponsor at all times. Anyone sponsoring a guest to the SRC at Western Michigan University is responsible for any misconduct on the part of themselves and/or their guests.

Family Policy

Members may bring family members with them while using the SRC. Family members over the age of 16 must pay the guest pass fee and adhere to the guest pass policy. Children aged 14-15 may use all areas of the SRC, but must be under direct supervision of parent/guardian. Children under the age of 13 are not eligible to use the indoor track, cardio equipment or weight room.

Misconduct Policy

All SRC members, currently enrolled students and guests are responsible for their own conduct upon entering the facility. Misconduct will not be tolerated under any circumstance. Misconduct includes, but is not limited to, verbal abuse, physical violence, facility damage, gambling, theft, unauthorized entrance or use of any University Recreation facility or property, violation of any law, department or University policy.

Membership Refund Policy

For members that pay membership fees in the University Recreation Office, you may apply for a full refund prior to the start of any semester or session. After the first day of any semester or session, a refund cannot be issued for any reason. Faculty or staff that use the benefits package to purchase an annual membership may not be issued a refund for any semester or session, for any reason, after signing up for an annual membership.

Parking Notice

Parking in Lot 13 (East entrance) is free after 5 p.m. Monday through Thursday, free after 4 p.m. on Friday, and free on Saturday and Sunday. During special events held on campus, parking lots near the SRC may charge a fee. University Recreation staff does not make decisions regarding parking on campus but will make every attempt to keep patrons informed. WMU affiliates (alumni, contributors, spouses, WMed employees) who have paid the SRC facility fee are eligible to purchase a WMU parking sticker for Lot #13. Students do not qualify.
