Mary Lagerwey called the meeting to order at 2:00.

Housekeeping

- Mary Lagerwey agreed to take minutes for this meeting.
- The agenda for the March 2024 meeting was approved
- Notes from the January meeting were approved

Updates

- Updating the Emeriti webpage
 - Mary has been working with the marketing section of the Office of the Provost to update the information on areas such as the emeriti newsletters, presentations, EC leadership. Members of the EC are asked to check on the site regularly and make note of information that needs to be updated.
- Faculty Senate
 - O The Faculty Senate notified Mary that one of the emeriti representatives to the Senate has not attended any meetings. She will be notified that if she wishes to continue as a representative, she needs to notify the EC and attend meetings. Otherwise, the position will be opened for a new emeriti representative.
- OLLI
 - O Barbara Hemphill attended the annual OLLI (Osher Lifelong Learning Institute of WMU) Board meeting in November 2023. She and Toni Woolfork-Barnes, Director of OLLI discussed ways in which the Emeriti Council and OLLI might assist each other in disseminating information about learning opportunities. This could include announcements in OLLI's monthly newsletter and on their website about upcoming Wednesday II events. A discussion followed, during which it was suggested that the EC contact Amy Brimmer from HR to explore the possibility of setting up a facebook account for the EC.

Updates

Faculty Senate

- One of the emeriti representatives to the Faculty Senate has not replied to a written request from Mary that she notify the EC if she wishes to continue as a representative, she needs to notify the EC and attend meetings. As of today, she has not attended any Faculty Senate meetings or participated in other Faculty Senate activities. John Jellies, Professor Emeritus Biology and past president of the Faculty Senate, has asked to be an emeriti representative to the Faculty Senate. The EC unanimously approved his request.
- Due to the break between Spring and Summer I sessions, the Faculty Senate has scheduled its May meeting for May 9 instead of the first Thursday in May. Mary Lagerwey will report on the May 2024 Faculty Senate meeting at the September EC meeting.

Guest: Toni Woolford-Barnes, Director of OLLI

Housekeeping

Mary Lagerwey introduced a new member of the Emeriti Council, Stan Robin, Professor Emeritus of Sociology.

- Mary Lagerwey agreed to take minutes for this meeting.
- The agenda for the September 2024 meeting was approved.
- Minutes from the May 2024 meeting were approved, with a correction stating that Stan Robin would be giving a performance, not a presentation.

Updates

- Faculty Senate
 - The Faculty Senate met on May 9, 2024. New members of the Senate were introduced, including the new President, Dr. Amy Naugel.
 - O John Jellies, a new emeriti representative to the Faculty Senate, met with Mary Lagerwey to review the Senate Constitution and Bylaws. They are going through their periodical review, and it is proposed that the following language be included in the Constitution and Bylaws.

Constitution

o Article IV: Membership of the senate

- Sec. 1. The Senate shall consist of ex officio, appointed, and elected members as follows:
- Ex officio: the president of the University, the provost, the chair of each Senate council and all past presidents of the Faculty Senate. For purposes of determining a quorum for any meeting of the Senate, the absence or presence of past presidents of the Senate shall not be counted.
- Appointed: four of the officers of the administration, appointed by the president of the University for a term of one year each, in accordance with the provisions of the bylaws. Appointed members of the Senate need not hold academic rank.
- o · Elected:
- 1. Representatives-at-large: nine representatives-at-large elected by the eligible voters of the faculty for a term of three years each, in accordance with the provisions of the bylaws.
- 2. Departmental representatives: representatives elected for three-year terms by and from faculty members of each University department, in accordance with the provisions of the bylaws. Substitutes for departmental representatives may be provided for in the bylaws.
- o 3. The president and vice president and other officers of the Senate.
- 4. Former faculty members who have retired as emeriti of WMU, selected by the Emeriti Council in accordance with the provisions of the bylaws (Article I, Sec. 7). Three emeriti will serve staggered three-year terms, with full membership and voting privileges in the Senate. Membership of the Emeriti Council shall be elected by the emeriti at large.

Bylaws

- o Article VII: Committees
- Sec. 1. In addition to those committees named in Article VII, Part 2, Sec. 2, of the constitution, the following shall be standing committees of the Senate:
 Professional Concerns, Centers and Institutes, Emeriti and WMU Essential Studies Executive Advisory.
- O Sec. 2. The Senate Executive Board shall nominate members and chairpersons for all standing committees and any ad hoc or special committees except for the Emeriti Committee, which is established according to Article IV, section 1. bullet 4 of the Constitution. The final determination and official appointment of committee memberships (except for the Emereti Committee) shall be made by the Senate Executive Board.
- Sec. 3. A vacancy on a standing committee shall be filled by the Senate Executive Board when notified of such vacancy by the chairperson of the standing committee.
- Sec. 4. All voting members of standing committees of the Faculty Senate shall have the right to propose motions and vote in their respective committees.

Wednesday II events

• Stan Robin is scheduled to offer his annual "Monologues" performance tomorrow, September 11, in the Heinig Emeriti lounge.

- At this point, no additional presentations have been scheduled. Suggestions discussed include theatre careers, Kercher Center research that benefits the community, a readers' theatre, and climate change. EC members are encouraged to contact potential presenters.
- Stan Robin noted that he has not been getting group emeriti email but does receive email messages sent directly. The EC discussed possible causes, and Lagerwey will follow up with the staff person who manages the emeriti email list to make sure his address is included in the list. She also reminded EC members that she sends out paper copies of Wednesday II announcements and the newsletter to emeriti who do not use email and encouraged EC members to notify here of any additional emeriti who would appreciate a paper copy.

Other possible events

EC members discussed the importance of emeriti gatherings and the loss of some previous events. These include the annual 25-year club celebration, retirement celebration, and a fall breakfast. Some of the loss has been due to the change placing the EC under the Office of the Provost instead of the President's Office, and no individual being specifically assigned to support the EC. It was agreed that the EC would explore options for a holiday gathering in December. Mary had talked with the CHHS representative from the Development Office about the possibility of that office assisting with planning and managing such an event. Stan noted that the development office should be expected to have an interest in emeriti as they can provide significant funding through wills and other donations. He also suggested a fund raiser with this office, perhaps in conjunction with a re-instituted retirement dinner.

The following factors would need to be addressed for a social gathering:

- Venue possibly the Fetzer Center or the Student Center
- Food
- Speaker
- Music

Peter suggested working more closely with the Faculty Senate if they approved the changes to their constitution and bylaws, making the EC a more direct part of the Senate structure. He also noted the importance of publicity if such a change is made.

Mary has reviewed WMU Board of Trustees' minutes and has not been able to find any references to the Board approving the establishment of the Emeriti Council or its support.

There was a general discussion about how to encourage the WMU administration to recognize the value of the emeriti to the University.

- Faculty Senate October 3 meeting: Mary reported that no action was taken on the proposed changes to the Senate Constitution and Bylaws. Vice President C. Dennis Simpson gave the first reading of the Senate <u>Constitution</u> and <u>Bylaws</u> amendments that will be voted on at the Nov. 7 meeting.
- Mary agreed to forward to EC members copies of the Faculty Senate Snapshot, an unofficial summary of each senate meeting sent out before official minutes are approved.

Communication received regarding Faculty Recognition event: an emeritus professor contacted Mary Lagerwey to request re-institution of events such as the faculty dinner.

The motion was passed unanimously. Mary Lagerwey will follow up with the Secretary of the WMU Board of Trustees.

She also will inquire about any documentation in WMU BOT minutes about the establishment of the WMU Emeriti Council in the 1970s.

It also was agreed that the EC should wait for the new WMU president rather than requesting a meeting with the current president, who is retiring from WMU in 2025.

Stan suggested that in preparation for a meeting with a new WMU President, the Emeriti Council should revise its Statement of Purpose and prepare an introduction about the Emeriti Council, its current role, and potential value to the University.
