University Strategic Plan

- Comments were provided by Faculty Senate leadership regarding this month's focus area [Community Building](#).

Action Items

- The Faculty Senate Executive Board put forward [amendments](#) to its Bylaws for a first reading. This action item will come forward for a vote of the Senate at the Dec. 4 meeting.

Informational Items

- Lisa Garcia, Associate Vice President for External Partnerships provided a [WMU External Partnership](#) report.
- Heather Stanley, Senior Director for Alumni Engagement provided a [Community Building through Alumni Engagement](#) report.
- University General Counsel, Keith Hahn, reported about Scholarship Administration, with principles that extend to program compliance, employee resource groups, and admissions practices. A comprehensive review of scholarship programs and related operations is underway to ensure alignment with legal requirements and institutional mission. Federal civil-rights statutes prohibit discrimination based on race, color, national origin, and sex in federally funded education, with the exception of Native American peoples. Additionally, Hahn addressed faculty concerns regarding immigration enforcement on campus. He is committed to a re-evaluation of the federal guidance webpage, particularly in the area of classrooms, to clarify existing guidance. The focus remains on minimizing risk and maintaining safety for faculty, staff, and students while ensuring that interactions are limited to law enforcement and designated administrative officials. Overall, this remains a complex and fluid area requiring collaboration between faculty and administration to define and maintain appropriate privacy expectations. Hahn reiterated what WMU's guidance has been, that it is recommended to contact the campus police who will come to the scene.
