Our Mission:

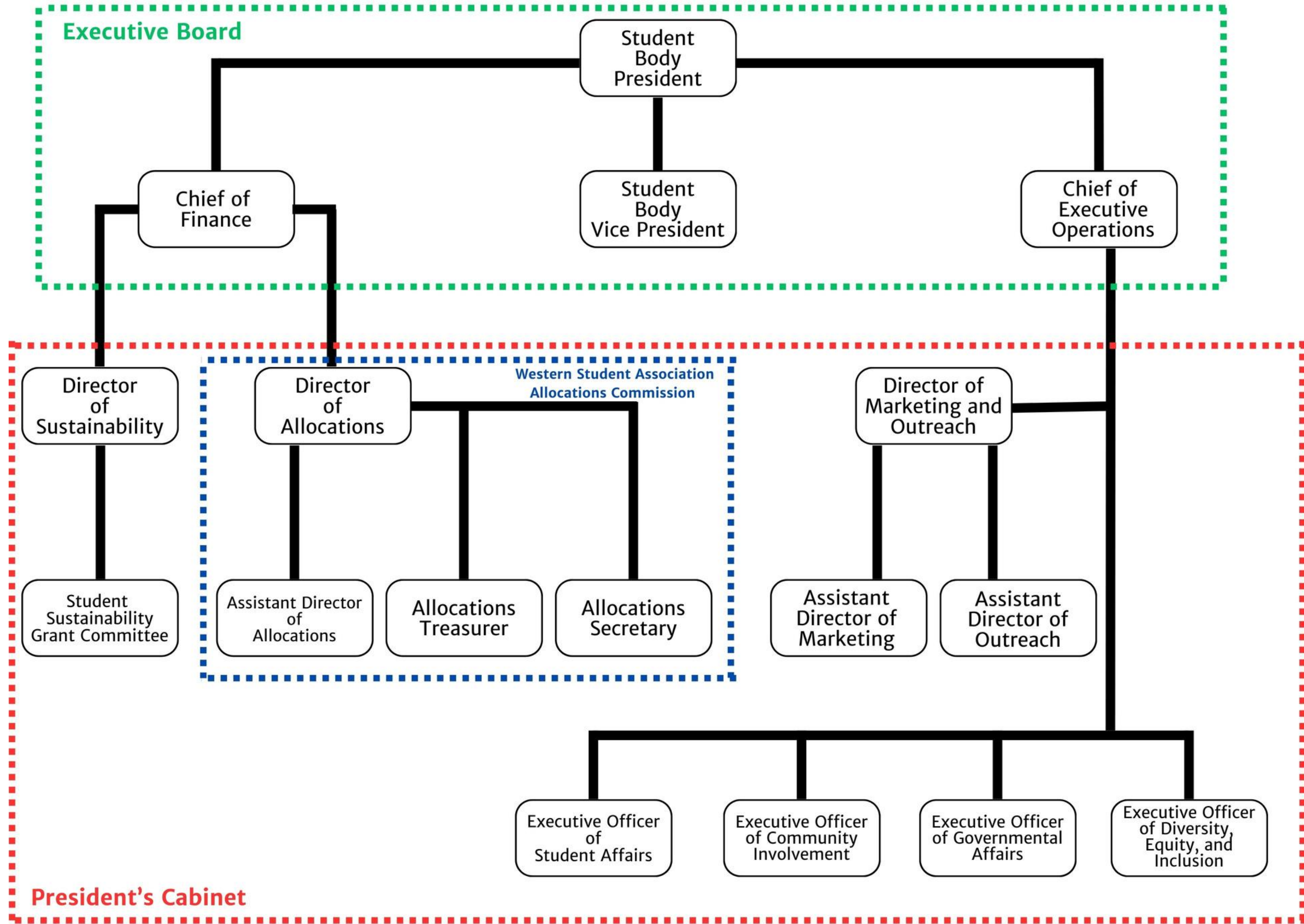
We exist to unify students, amplify their voices, and provide new opportunities to leave a legacy.

- Civic Engagement Week, Diversity Week, Mental Health Week, Green Week*

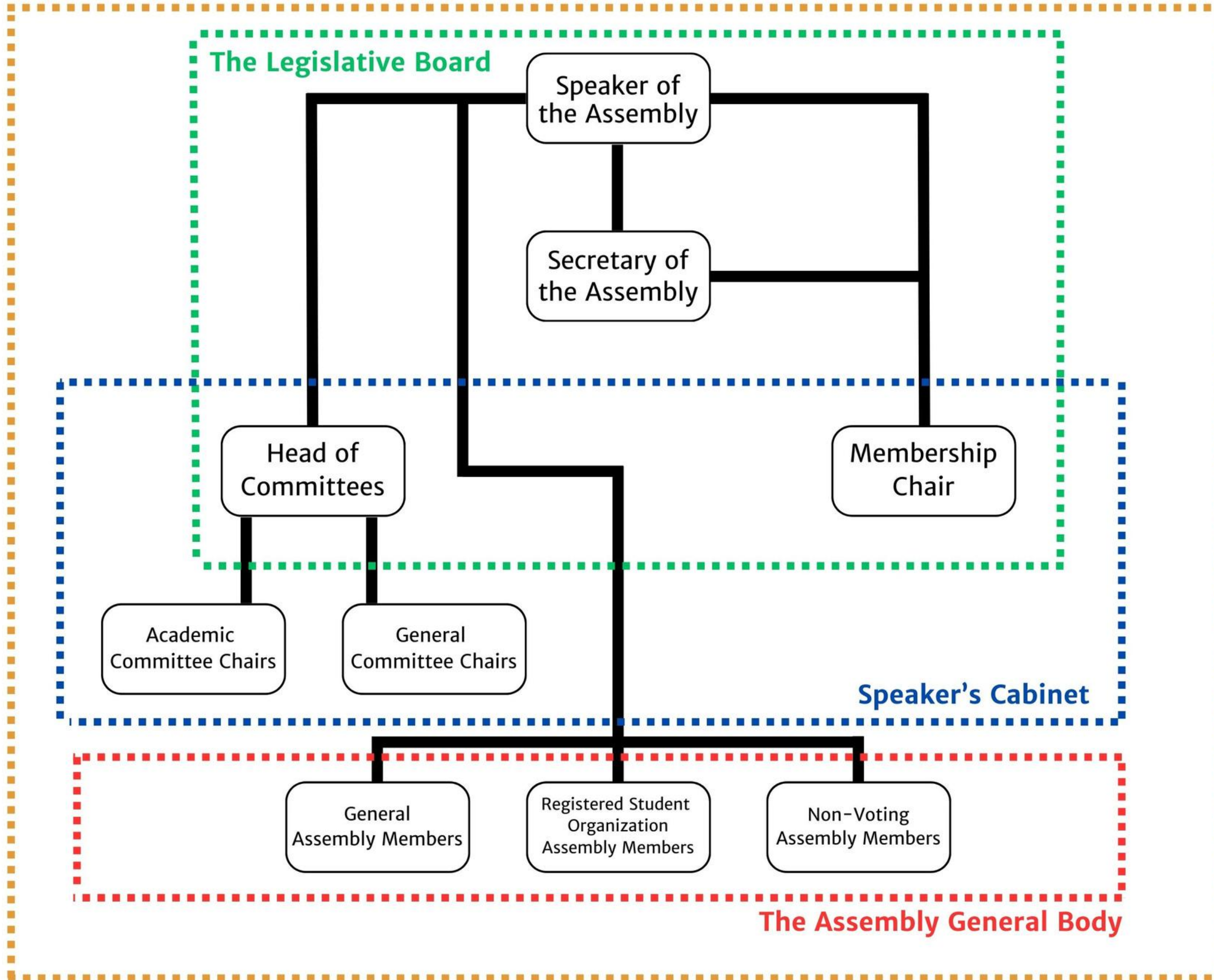
Individual Events:

- *Three ad-hoc committees*

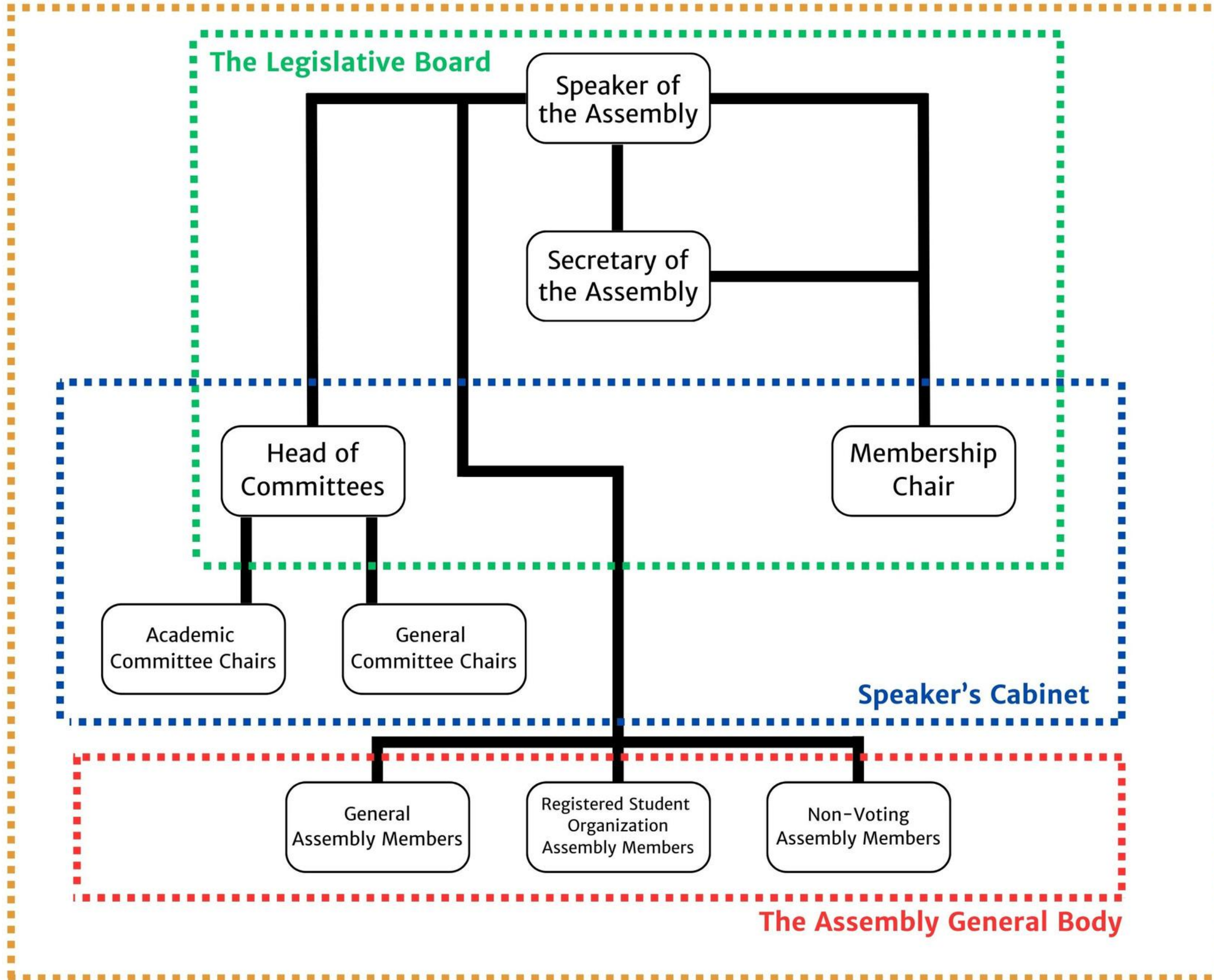
Legislation passed this year includes:
