Reports of University Representatives

Byrd-Jacobs reported that the Graduate College offered finals week treats in Graduate Commons in Waldo Library. There are plans for a meet-up social gathering for graduate students in the spring semester. The Graduate College is expanding offerings for professional development materials and resources for graduate students. It was discovered that there were cases of students who had repeated courses that were not listed as repeatable for credit, sometimes at the direction of the department. This may be an administrative issue. Graduate College is working with departments individually and notifying departments that, going forward, students who retake a course will have their most recent grade supersede their previous grade. Departments that wish to change courses to allow for repeat credit will need to go through the curriculum change process. Steve Way, Associate Director of Recruitment and Marketing at Graduate College, is no longer with WMU, and his responsibilities are currently being overseen by others in the College.

DeChano-Cook reported that there is a disparity in the types of information included for programs in the graduate catalog compared with the undergraduate catalog. This is a problem for those students engaging in an Advanced Graduate Degree Program since they are not always able to figure out what the required courses are at the graduate level for an Accelerated Graduate Degree Program (AGDP). DeChano-Cook asked GSC if it would be appropriate to develop a set of guidelines for programs listed in the graduate catalog. GSC will consider this in future meetings.

Medina reported that the Graduate Student Association (GSA) will continue to collaborate with different offices/departments on campus to make sure that graduate students are aware of the services available. The next GSA general assembly will include presentations/updates from Haenicke Institute for Global Education (HIGE) on issues surrounding insurance for international students. GSA is collaborating with Waldo Library to revamp the Graduate Commons space. Graduate students have been surveyed about their use and needs. \$18,000 have been used to support graduate students attending conferences. GSA continues to remind students that graduate college offers financial support for students presenting at conferences and for students attending conferences. Information about requesting this funding is on ExperienceWMU. The Three-Minute Thesis competition will be held on 18 February 2025 from 2 to 4 p.m. in the Student Center Ballroom. GSA will be recruiting faculty to judge the competition. Contact Byrd-Jacobs if interested in judging.

Unfinished Business

GSC reviewed the draft language of the Proposed Language for Memorandum of Action (MOA) on Establishment of Credit Transfer Policy for Graduate Certificates. Byrd-Jacobs will write a formal MOA for consideration at a future meeting.
