

**RESEARCH POLICIES COUNCIL  
Minutes of 12 May 2022****Call to Order**

The regular meeting of the Western Michigan University Faculty Senate Research Policies Council was called to order at 2:33 on 12 May 2022, via Webex video conferencing by Sarah Summy.

**Quorum**

A quorum was present.

**Acceptance of Agenda**

**[MOTION]** It was moved by DeCamp, seconded by Venter, to accept the agenda as amended to include a FRACAA addition to new business. The motion carried unanimously.

**Election of officers**

**[MOTION]** It was moved by Summy, seconded by Carr, to nominate Andre Venter as chair. Venter accepted the nomination. The motion carried unanimously.

**[MOTION]** It was moved by DeCamp, seconded by Carr, to nominate Onur Arugaslan as vice chair. Arugaslan accepted the nomination. The motion carried unanimously.

**Approval of Minutes**

**[MOTION]** It was moved by Carr, seconded by Hurwitz, to approve the minutes of 14 April 2022. The motion carried unanimously.

**Reports of Officers**

Ex Officio Summy thanked the Research Policies Council for its work and looks forward to the upcoming passing of the Memorandum of Actions.

**Reports of University Representatives**

Interim Vice President for Research and Innovation Carr noted that he is in the process of transferring duties and responsibilities to the new Vice President for Research and Innovation. Venter asked about the rollover of funds for this council's activities from this year to next, and there was no indication that the funds would not be carried over.

Graduate College Dean Byrd-Jacobs was not present.

**Reports of Council/Committee Standing Committees**

Research Screening Committee

Ex Officio Hurwitz is still operating as Bautista's replacement.

**[MOTION]** It was moved by DeCamp, seconded by Venter, to appoint Hurwitz as the official FRACAA chair. The motion passed unanimously.

Ex Officio Hurwitz indicated that the FRACAA awardees have been notified of this year's awards. Hurwitz supports the move to increase the FRACAA award amounts and the SFSA limits. SFSA or PPP&E might be a place where publication subvention funds might be created. DeCamp noted that the PPP&E structure

could be revised so that the current structure is maintained, but another mechanism is created so that faculty could apply for a higher amount to cover extensive publication costs. This, in addition to updating the PPP&E guidelines, could be added to the charges for the council next year.

### **Unfinished Business**

Renaming of the Office of Vice President for Research and Innovation

Arugaslan circulated the draft council year-end report prior to the meeting. Feedback was gathered from RPC members.

### **New Business**

Venter noted that the FRACAA amounts have not been updated for quite some time and suggested that raising it to \$15,000 might make sense, as well as changing application requirements so that as soon as a faculty member satisfies the requirements of an award, they would be eligible to apply for another FRACAA. DeCamp suggested that RPC members come to the September meeting with revised dollar amount ideas for each of the four funding mechanisms.

**[MOTION]** It was moved by DeCamp, seconded by Councill-Vargas, to increase the maximum FRACAA award to \$15,000 as of now. Venter amended the motion to include an SFSA increase to \$3,000 with a re-evaluation of all funding mechanisms in the fall. The amended motion passed unanimously.
