
**RESEARCH POLICIES COUNCIL
Minutes of 9 February 2023****Call to Order**

The regular meeting of the Western Michigan University Faculty Senate Research Policies Council was called to order at 2:30 p.m. on 9 February 2023, via Webex video conferencing by Andre Venter, chair.

Chair Venter noted that RPC will invite Geri Rinna, Librarian Representative, after the upcoming library meeting. In the Support for Faculty Scholars Award (SFSA) process, many of the submitted proposals were funded, spending just over \$26,000 of the budgeted \$30,000. The eight funded applications included proposals 2480, 2487, 2455, 2492, 2486, 2449, 2495, and 2494.

Mays encouraged submission of community members for the WMU Institutional Review Board (IRB). There is a two-step process for adding students to the [Cayuse platform](#). Mays noted that the National Science Foundation requires a "safe and inclusive plan" for off-site compliance. Some of the aspects of the requirements were laid out in the context of how WMU is developing a procedure for researchers to use to comply with the requirements.

Mays left the meeting at 3:34 p.m.

Chair Venter encouraged members to review Charge #2: Recommendations and Memorandum of Action for Enhancing Interdisciplinary Research and Creative Collaborations at the College and Department Levels. There will be a discussion at the next RPC meeting. It was noted that the College of Arts and Sciences has a process to financially support interdisciplinary projects. The idea of FRACAA being modified to contain a process by which it could encourage interdisciplinary projects was discussed, along with possible mechanisms for encouraging interdisciplinary collaboration and some of the obstacles seen in previous efforts.
